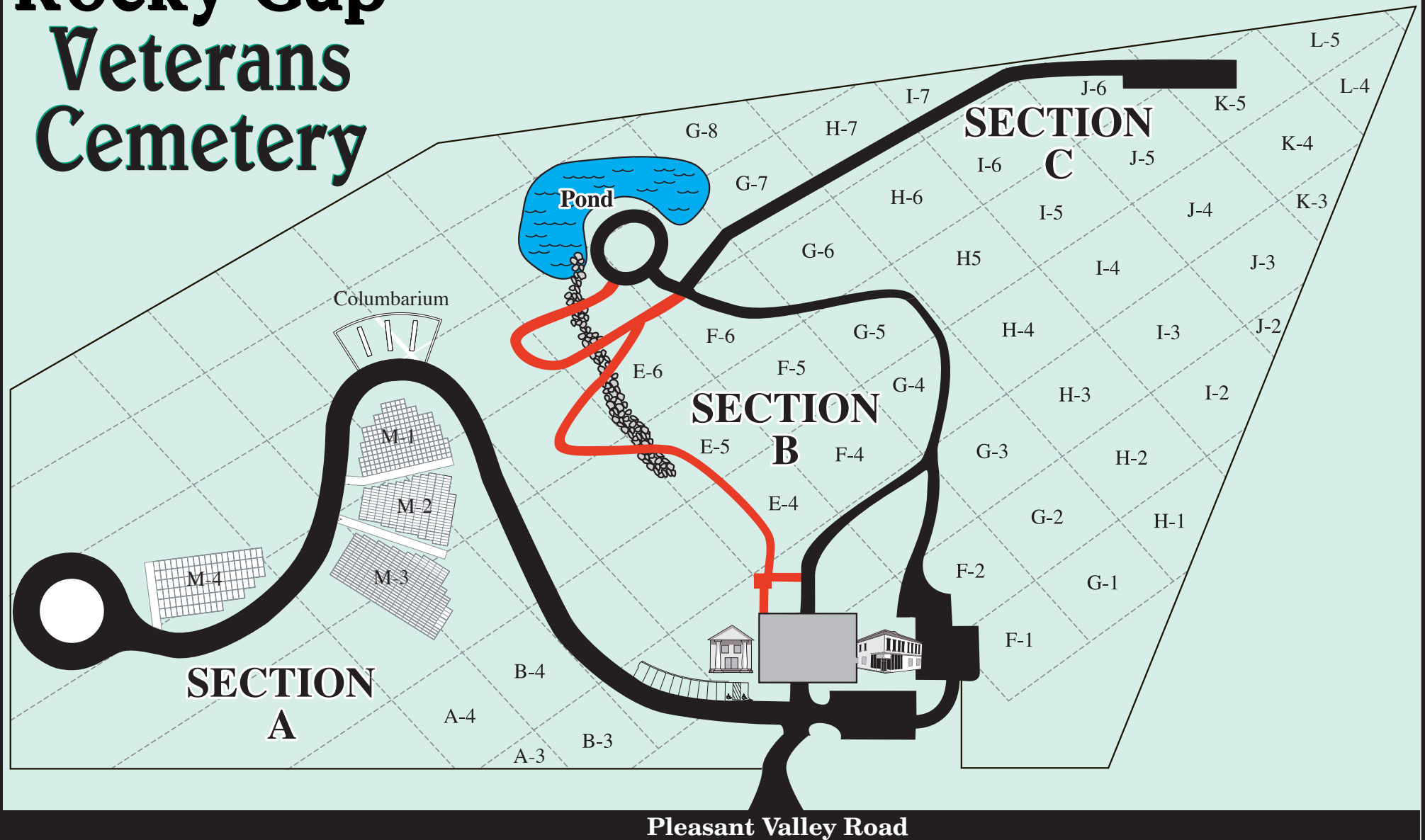


Rocky Gap Veterans Cemetery



General Information

— Rocky Gap Veterans Cemetery —

1. The cemetery will be open to visitors every day of the year from 8:00 a.m. to 5:00 p.m. The entrance gates will begin to close at 4:30 p.m. with all gates being closed by 4:45 p.m., excluding Memorial Day (the date of State observance) when the cemetery will remain open until 8:00 p.m.
2. Cut flowers may be placed on graves at any time (no glass containers). Floral arrangements will be removed when they become unsightly. During the growing season when grass requires cutting, all flowers - both fresh and unsightly - will be removed prior to grounds maintenance.
3. Effective September 1, 1997 the Maryland Veterans Cemeteries will no longer accept permanent in ground flower vases for installation at our facilities.
4. Artificial flowers and arrangements may only be placed on the graves from November 1st through March 31st. Potted plants and holiday wreaths may be placed on graves 10 days before through 10 days after Easter and Memorial Day. Christmas wreaths and grave blankets may be placed from December 1st through January 31st. Any arrangements that become unsightly or are blown about by weather conditions will be removed and disposed of by cemetery staff.
5. Potted plants (except as noted above), permanent plantings, statues, solar/vigil lights, glass objects of any kind, balloons, toys, stuffed animals, or similar kinds of commemorative items are not permitted on graves at any time. All unauthorized items will be removed and disposed of by cemetery staff.
6. Small United States flags will be placed on the graves by cemetery staff at least one day preceding Memorial Day and will be removed the following work day. On Veterans Day and Flag Day only; U.S. grave site flags (8" x 12") may be placed on graves by visitors, but must be removed by close of business that day. Flags are not permitted on graves at any other time.
7. Until growing conditions are favorable and adequate turf has been established burial areas may be unsightly in appearance. After the grave has been stabilized, and active burial operations moved to other areas, the overall appearance of an occupied section will improve. Meanwhile, the cemetery staff requests your understanding and asks that you refrain from placing sod or grass seed on the burial site.
8. Concerns or questions should be brought to the attention of the Cemetery Superintendent Monday through Friday between the hours of 8:30 a.m. and 4:00 p.m.
9. Pets, hunting, fishing, picnicking, bicycling, and running are prohibited on the cemetery grounds. Climbing of trees or removal/damage of vegetation, trees, and/or shrubs is also prohibited. Enjoy memories of your loved ones who are laid to rest here, and respect their memory by removing any litter or debris so that the cemetery grounds are kept in good order.
10. No personal vehicles are permitted to travel off paved roadways onto the cemetery grounds.
